

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving of Amendment No. 1 to the 638 Ranger Program FY 2015 budget)**

**RESOLUTION NO. 15-134**

1 **WHEREAS, the Tohono O'odham Nation contracts its own Law Enforcement, Ranger and**  
2 **Corrections Programs under the P.L. 93-638 BIA Master Contract; and**

3 **WHEREAS, the FY 2015 Ranger Program budget was approved by the Tohono O'odham**  
4 **Legislative Council through Resolution No. 14-348; and**

5 **WHEREAS, the Tohono O'odham Nation Police Department received carryover funding**  
6 **Submits a budget amendment No. 1 for its FY 2015 Ranger Program; and**

7 **WHEREAS, amendment No. 1 allows the creating of a new line item 7500 Major Capital,**  
8 **increase and decrease Personnel and Operational Expense line items; and**

9 **WHEREAS, the Domestic Affairs and Budget and Finance Committees of the Legislative**  
10 **Council have reviewed this budget amendment and recommends its approval.**

11 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
12 **approves the Budget Amendment No. 1 for Ranger Program FY 2015 budget to**  
13 **incorporate 2014 carryover savings in the amount of 283,421.03, to increase,**  
14 **decrease Personnel Expense and create new Capital Expense line item, which**  
15 **has increased the budget amount to 1,472,593.22 and increasing Indirect Cost to**  
16 **\$218,808.25.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**  
18 **the Chairperson and any designated official to expend and administer the**  
19 **budget as attached, provided that any amendments affecting the funds or**  
20 **funding level is submitted for further prior approval by the Tohono O'odham**  
21 **Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 05<sup>TH</sup>**  
23 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
24 **AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
25 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
28 **June 18, 1934 (48 Stat.984).**
