

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Ske:g Hihiosig/Beautiful Flowers Elder Garden Project Budget
in the amount of \$50,000.00)

RESOLUTION NO. 15-138

1 **WHEREAS, the Tohono O'odham Nation submitted an application for funding to the**
2 **Freeport McMoran Copper & Gold Foundation under the Native American**
3 **Partnership Fund for the Ske:g Hihiosig/Beautiful Flowers Elder Garden Project**
4 **and was awarded the amount of \$50,000.00 for creation of an outdoor gathering**
5 **area and garden for Elders at the Tohono O'odham Department of Health and**
6 **Human Services complex for Elders to 1) engage in cultural activities to promote**
7 **wellbeing and cultural exchange and 2) participate in health promotion through**
8 **the Elder Nutrition program; and**

9 **WHEREAS, by Tohono O'odham Legislative Council Resolution No. 14-181 accepted the**
10 **Notice of Award for completion of the project within one year for the creation of**
11 **an outdoor gathering area and garden for elders; and**

12 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 14-491 approved the FY2015**
13 **Budget for the Ske:g Hihiosig/Beautiful Flowers Elder Garden Project with an**
14 **expected completion date of March 1, 2015 which was not met due to difficulty in**
15 **securing a contractor; and**

16 **WHEREAS, the Grantor, Freeport-McMoran Native American Partnership Fund has**
17 **approved an extension for a period of 12 months, a budget of \$50,000.00 has**
18 **been prepared for the completion of the project; and**

19 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
20 **Legislative Council have reviewed the budget and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
22 **approves the FY2016 Ske:g Hihiosig/Beautiful Flowers Elder Garden Project**
23 **budget in the amount of \$50,000 to complete the Elder Garden Project for period**
24 **April 1, 2015 to March 31, 2016.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
26 **Chairperson and any designated official to expend and administer the budget as**
27 **attached, provided that any Amendments affecting the funds or funding level is**
28 **submitted for further prior approval by the Tohono O'odham Legislative**
29 **Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
31 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(d)(2)(3)&(f) and of the Constitution of the Tohono O'odham Nation,**
34 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
35 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
36 **16 of the Act of June 18, 1934 (48 Stat.984).**
