

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Credit & Finance Program FY 2015 Budget Amendment #1)**

**RESOLUTION NO. 15-139**

1 **WHEREAS, the Credit & Finance Program under the Planning and Economic Development**  
2 **Department is funded by BIA 638 Master Contract; and**

3 **WHEREAS, the Credit & Finance Program FY 2015 638 Budget was previously approved by**  
4 **Tohono O'odham Legislative Council Resolution No. 14-348; and**

5 **WHEREAS, the Credit & Finance Program has identified a need to utilize carryover savings**  
6 **from FY 2014 a budget amendment has been prepared and submitted for**  
7 **approval to its FY 2015 budget; and**

8 **WHEREAS, budget amendment #1 will increase Operational Line Items; and**

9 **WHEREAS, this amendment will also increase the Indirect Cost and the overall budget**  
10 **amount; and**

11 **WHEREAS, the Commerce and the Budget and Finance Committee of the Legislative Council**  
12 **have reviewed this budget amendment and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
14 **accepts and approves the Credit & Finance Program FY 2015 Budget Amendment**  
15 **#1 as follows:**

- 16 **1. Utilizing carryover savings in the amount of \$6,000.00**
- 17 **2. Increasing Operational Line Items**
- 18 **3. Increasing the Indirect Cost by \$1,020.50**
- 19 **4. Increasing the overall budget amount to \$296,117.93**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
21 **Chairperson and any designated official to expend and administer the**  
22 **budget as attached, provided that any amendments affecting the funds or**  
23 **funding level is submitted for further prior approval by the Tohono**  
24 **O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>th</sup>**  
26 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
28 **Article VI, Section 1(d)(3)and(f) and of the Constitution of the Tohono O'odham Nation, adopted**  
29 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
30 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
31 **Act of June 18, 1934 (48 Stat.984).**
