

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment #003 of the Cooperative Agreement L12AC20578 between
the Tohono O'odham Nation and US Bureau of Land Management and to Approve
FY 2015 SWMP - BLM Budget in the amount of \$84,094.09 which includes carry
forward of unobligated funds from FY-2014)**

RESOLUTION NO. 15-141

1 **WHEREAS, the Tohono O'odham Nation approved through resolution 12-500 Cooperative**
2 **Agreement L12AC20578 from the US Bureau of Land Management to fund**
3 **undocumented migrant and smuggler trash clean-up from October 1, 2012**
4 **through September 30, 2017 as stated in the Cooperative Agreement; and**

5 **WHEREAS, amendment #003 of Cooperative Agreement L12AC20578 between the Tohono**
6 **O'odham Nation and the U.S. Bureau of Land Management provides an**
7 **additional award of \$50,000.00 to be expended by September 30, 2015; and**

8 **WHEREAS, the funds are to be expended for clean-up of undocumented migrant and**
9 **smuggler waste including abandon vehicles impacting the Tohono O'odham**
10 **Nation; and**

11 **WHEREAS, the Solid Waste Management Program has been notified of unobligated funds of**
12 **\$34,094.09 that is added to the FY 15 budget; and**

13 **WHEREAS, the Agricultural and Natural Resources and the Budget and Finance Committees**
14 **of the Legislative Council have reviewed this Budget and recommend its**
15 **approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council accepts and**
17 **approves:**

- 18 **1) The cooperative agreement amendment #003 to contract L12AC20578**
19 **between the Tohono O'odham Nation and the U.S. Bureau of Land**
20 **Management an award of \$50,000.00.**
- 21 **2) Carry forward \$34,094.09 of unobligated funds from FY-14 budget.**
- 22 **3) Approve FY 2015 SWMP - BLM Budget in the amount of \$84,094.09.**

23 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the budget as**
25 **attached, provided that any amendments affecting the funds or funding levels is**
26 **submitted for further prior approval by the Tohono O'odham Legislative**
27 **Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06TH**
29 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2)(3)and(f) and of the Constitution of the Tohono O'odham Nation,**
32 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
33 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
34 **16 of the Act of June 18, 1934 (48 Stat.984).**






