**RESOLUTION NO. 15-142**

1 **WHEREAS, the Tohono O'odham provides services to improve the availability, affordability**  
2 **and quality of child care through funding provided by the Arizona Department**  
3 **of Economic Security (ADES) Planned Social Services Block Grant (SSBG) Title XX**  
4 **Program; and**

5 **WHEREAS, the Tohono O'odham Nation has entered into a cost-reimbursement**  
6 **Intergovernmental Agreement with ADES for Planned Social Services Title XX**  
7 **Block Grant pursuant to Resolution No. 13-256, Contract Number ADES14-**  
8 **053077; and**

9 **WHEREAS, the contract reimbursement ceiling for the project period of July 1, 2015,**  
10 **through June 30, 2016 is \$99,612.00; and**

11 **WHEREAS, an Itemized Service Budget for Arizona Department of Economic Security is**  
12 **attached and added to this Agreement; and**

13 **WHEREAS, the Human Resources Development Committee of the Tohono O'odham**  
14 **Legislative Council have reviewed Amendment No. 3 and recommend its**  
15 **approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
17 **approve Amendment No. 3 to the Arizona Department of Economic Security**  
18 **Planned Social Services Title XX Block Grant Intergovernmental Agreement**  
19 **#ADES14-053077.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
21 **Chairperson of the Tohono O'odham Nation to execute Amendment No. 3,**  
22 **provided that any amendments affecting the funds or funding level shall be**  
23 **submitted for further prior approval by the Tohono O'odham Legislative**  
24 **Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
26 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
28 **Article VI, Section 1(f) and of the Constitution of the Tohono O'odham Nation, adopted by the**  
29 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
31 **June 18, 1934 (48 Stat.984).**


