

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Authorizing the U.S. Department of Interior Office of Special Trustee to Return Funds to**  
**the Proper Accounts Held at the U.S. Department of Interior Office of Special Trustee)**

RESOLUTION NO. 15-144

1 **WHEREAS, the Constitution of the Tohono O'odham Nation (the "Nation") vests the Tohono**  
2 **O'odham Legislative Council with legislative and fiscal powers, including the**  
3 **power "to manage any funds within the exclusive control of the Tohono O'odham**  
4 **Nation, including proceeds derived from lands and resources of the Tohono**  
5 **O'odham Nation" (Constitution, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, in a letter dated March 30, 2015, the U.S. Department of Interior Office of Special**  
7 **Trustee (the "OST") reported erroneous payments made on April 4, 2013 to**  
8 **proceeds of labor account PL7505701 held for all districts in the amount of**  
9 **\$10,111.15 and proceeds of labor account PL7409706 held for the Tohono**  
10 **O'odham Nation in the amount of \$300.00; and**

11 **WHEREAS, OST reported that \$10,111.15 is to be returned from proceeds of labor account**  
12 **PL7505701 to account 610T610-10 and then transferred into San Xavier District**  
13 **proceeds of labor account PL7506709, and \$300.00 is to be returned from**  
14 **proceeds of labor account PL7409706 to account 610T610-10; and**

15 **WHEREAS, the U.S. Department of Interior Office of Special Trustee requests the Nation to**  
16 **pass a tribal resolution authorizing the OST to return these funds to the proper**  
17 **accounts held at the U.S. Department of Interior Office of Special Trustee; and**

18 **WHEREAS, the Investment Committee reviewed the letter on April 30, 2015 recommends**  
19 **that these funds be returned.**

20 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it**  
21 **authorizes the U.S. Department of Interior Office of Special Trustee to return the**  
22 **funds to the proper accounts as follows:**

- 23 (1) **\$10,111.15 is to be returned from proceeds of labor account PL7505701 to**  
24 **account 610T610-10 and then transferred into San Xavier District**  
25 **proceeds of labor account PL7506709; and**  
26 (2) **\$300.00 is to be returned from proceeds of labor account PL7409706 to**  
27 **account 610T610-10.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 06<sup>TH</sup>**  
29 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
30 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
31 **Article VI, Section 1(d)(2) and of the Constitution of the Tohono O'odham Nation, adopted by**  
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
34 **June 18, 1934 (48 Stat.984).**
