1 **WHEREAS, by Resolution No. 14-502 the Nation approved an Attorney Contract with**  
2 **Attorney at Law Lawrence Boswell; and**

3 **WHEREAS, the Advocate Program recommends approval of Amendment No. 1 to the**  
4 **Attorney Contract; and**

5 **WHEREAS, funding for the amended Attorney Contract will come from the budget of the**  
6 **Tohono O'odham Advocate Program; and**


7 **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed**  
8 **Amendment No. 1 to the Attorney Contract and recommend approval by the**  
9 **Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11 **1. The Tohono O'odham Legislative Council approves Amendment No. 1 to**  
12 **the Attorney Contract with Attorney at Law Lawrence Boswell for FY**  
13 **2015 substantially in the form attached hereto.**
- 14 **2. The Chairperson of the Nation is authorized to execute Amendment No. 1**  
15 **to the Attorney Contract.**

17 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,406.65 FOR;**

19 **Council by Article VI, Section 2(a) and of the Constitution of the Tohono O'odham Nation,**  
20 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
21 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
22 **16 of the Act of June 18, 1934 (48 Stat.984).**
