1   **WHEREAS, by Resolution No. 14-505 the Nation approved an Attorney Contract with**  
2                   **Attorney at Law Anthony Payson II; and**  
3   **WHEREAS, the Advocate Program recommends approval of Amendment No. 1 to the**  
4                   **Attorney Contract; and**  
5   **WHEREAS, funding for the amended Attorney Contract will come from the budget of the**  
6                   **Tohono O'odham Advocate Program; and**  
7   **WHEREAS, the Domestic Affairs and Budget and Finance Committees have reviewed**  
8                   **Amendment No. 1 to the Attorney Contract and recommend approval by the**  
9                   **Legislative Council.**

10 **NOW, THEREFORE, BE IT RESOLVED that:**

- 11                   1.     **The Tohono O'odham Legislative Council approves Amendment No. 1 to**  
12                             **the Attorney Contract with Attorney at Law Anthony Payson II for FY**  
13                             **2015 substantially in the form attached hereto.**
- 14                   2.     **The Chairperson of the Nation is authorized to execute Amendment No. 1**  
15                             **to the Attorney Contract.**

21 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
22 **16 of the Act of June 18, 1934 (48 Stat.984).**
