1	WHEREAS	the Tohono O'odham Legislative Council is vested with the power to establish
2		rules and procedures to regulate all meetings of the Tohono O'odham
3		Legislative Council, standing committees, boards and special committees
4		(Constitution of the Tohono O'odham Nation, Article VI, Section 1(a) and (b)); and
5	WHEREAS,	the Legislative Council has adopted and amended the Legislative Rules of the
6		Tohono O'odham Legislative Council ("Legislative Rules") to govern the general
7		structure of the Council's standing committees; and
8	WHEREAS,	Article XI, Section 2(C) of the Legislative Rules provides that "The Rules
9		Committee shall review and make recommendations on proposed legislative
10		committee plans of operation and amendments to plans of operation to the
11		Legislative Council."; and
12	WHEREAS,	the Plan of Operation for the Rules Committee also delegates to the Committee
13		jurisdiction over Legislative Council committee organization and plans of
14		operation (Rules Plan of Operation, Article III.C.2.(a)); and
15	WHEREAS,	on October 30, 2012 by Resolution No. 12-423, the Legislative Council approved
16		Tohono O'odham Nation Code, Title 27, Chapter 1, Creation of the Hia-Ced
17		District of the Tohono O'odham Nation; and
18	WHEREAS,	the Legislative Council by Legislative Order No. 13-153 amended plans of
19		operation for the Legislative Council's Budget and Finance, Domestic Affairs,
20		and Health and Human Services Committees to increase the number of
21		committee members from five to seven and adjust quorums to accommodate
22		two additional representatives from the Hia-Ced District; and
23	WHEREAS,	effective April 25, 2015 the Nation's voters enacted Initiative INT-01-14, thereby
24		dissolving the Hia-Ced District and the two Legislative Council seats for Hia-Ced
25		representatives; and
26	WHEREAS,	the Rules Committee therefore recommends that the Council approve amended
27		plans of operation for the Budget and Finance, Domestic Affairs, and Health and
28		Human Services Committees as dated for reference June 2015 to allow each
29		Council representative to serve on three standing committees.
30	NOW, THERE	EFORE, BE IT ORDERED that the Tohono O'odham Legislative Council adopts the
31		amended plans of operation for the Budget and Finance, Domestic Affairs, and
32		Health and Human Services Committees as dated for reference June 2015.
