

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Nominating Representative Chester Antone to the Department of Health and
Human Services Secretary's Tribal Advisory Committee)**

RESOLUTION NO. 15-150

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the authority "to promote, protect and provide for public health, peace,**
3 **morals, education and general welfare of the Tohono O'odham Nation and its**
4 **members..." and with the authority to "consult, negotiate and conclude**
5 **agreements and contracts on behalf of the Tohono O'odham Nation with**
6 **Federal, State and local governments and other Indian tribes...within the**
7 **authority of the Tohono O'odham Council." (Constitution, Article VI, Section**
8 **1(c)(2) and Section 1(f)); and**

9 **WHEREAS, the U.S. Department of Health and Human Services ("HHS") Secretary's Tribal**
10 **Advisory Committee ("STAC") was established in 2010 representing the highest**
11 **level tribal advisory committee in the HHS and is intended as a forum for**
12 **government-to-government consultation; and**

13 **WHEREAS, the STAC's primary purpose is to identify issues and priorities, seek consensus,**
14 **exchange views, share information, and provide advice and recommendations,**
15 **and coordinate with HHS agencies on all matters related to improving health**
16 **and human services and ensuring tribal consultation on HHS policies affecting**
17 **American Indian and Alaska Native ("AI/AN") communities (STAC Charter); and**

18 **WHEREAS, the STAC's tribal representation is comprised of seventeen positions to be filled**
19 **by voluntary representatives: one delegate (and one alternate) from each of the**
20 **twelve Indian Health Service ("IHS") areas and one delegate (and one alternate)**
21 **for five National At-Large Tribal Member positions; and**

22 **WHEREAS, Representative Chester Antone serves as the STAC Tucson Area delegate with a**
23 **term expiring May 2015; and**

24 **WHEREAS, the Health and Human Services Committee recommends the nomination of**
25 **Representative Chester Antone to the STAC for another term.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates**
27 **Representative Chester Antone to serve as Tucson Area delegate on the**
28 **Secretary's Tribal Advisory Committee.**

29 **BE IT FINALLY RESOLVED that an appointment made pursuant to this resolution shall**
30 **immediately expire if the appointed representative no longer serves on the**
31 **Health and Human Services Committee for any reason.**
