		level tribal advisory committee in the HHS and is intended as a forum for
		government-to-government consultation; and
	WHEREAS,	the STAC's primary purpose is to identify issues and priorities, seek consensus,
		exchange views, share information, and provide advice and recommendations,
		and coordinate with HHS agencies on all matters related to improving health
i		and human services and ensuring tribal consultation on HHS policies affecting
I		American Indian and Alaska Native ("AI/AN") communities (STAC Charter); and
	WHEREAS,	the STAC's tribal representation is comprised of seventeen positions to be filled
		by voluntary representatives: one delegate (and one alternate) from each of the
		twelve Indian Health Service ("IHS") areas and one delegate (and one alternate)
		for five National At-Large Tribal Member positions; and
	WHEREAS,	Representative Chester Antone serves as the STAC Tucson Area delegate with a
Ì		term expiring May 2015; and
	WHEREAS,	the Health and Human Services Committee recommends the nomination of
		Representative Chester Antone to the STAC for another term.
	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council nominates
		Representative Chester Antone to serve as Tucson Area delegate on the
		Secretary's Tribal Advisory Committee.
	BE IT FINAL	LY RESOLVED that an appointment made pursuant to this resolution shall
		immediately expire if the appointed representative no longer serves on the
		Health and Human Services Committee for any reason.
