

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Amendment No. 1 of FY 2014 Carry Forward Funds to the
FY 2015 Range Conservation and Management Program BIA Budget)

RESOLUTION NO. 15-153

1 **WHEREAS, the Tohono O'odham Legislative Council approved the Range Conservation and**
2 **Management Program (BIA) through Resolution No. 14-348 in the amount of**
3 **\$694,561.21; and**

4 **WHEREAS, the Grants and Contracts Office has identified FY 2014 carry forward savings in**
5 **the amount of \$155,878.61; and**

6 **WHEREAS, the Range Conservation and Management (BIA) Program is requesting that the**
7 **carry forward savings in the amount of \$129,681.18 be added to the FY 2015**
8 **Range Conservation and Management (BIA) Program Budget and the remaining**
9 **funds of \$26,197.43 allocated to the Agriculture Extension FY 2015 Budget; and**

10 **WHEREAS, the Range Conservation and Management Program has prepared budget**
11 **amendment No. 1 increasing operational expense line items and budget total;**
12 **and**

13 **WHEREAS, the Agricultural and Natural Resources and the Budget and Finance Committees**
14 **of the Legislative Council have reviewed this budget and recommend its**
15 **approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
17 **approves Amendment No. 1:**

- 18 **1. Approve to base increase of \$6,026.76**
- 19 **2. Approve utilizing carry forward savings in the amount of \$129,681.18 to be**
20 **added to the Range Conservation and Management Program FY 2015 budget**
- 21 **3. Approve increasing operational expense line items**
- 22 **4. Approve increasing Range Conservation and Management Program base**
23 **budget amount to \$712,538.11 and indirect cost to \$145,429.03 with a revised**
24 **budget of \$857,967.14**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
26 **Chairperson and any designated official to expend and administer the budget,**
27 **as attached, provided that any amendments affecting the funds or funding levels**
28 **of the budget shall be submitted for further approval by the Tohono O'odham**
29 **Legislative Council.**



7 **Act of June 18, 1934 (48 Stat.984).**




