

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Amendment No. 1 to include FY 2014 carry forward savings to the  
FY 2015 Agriculture Extension Program BIA Budget)**

**RESOLUTION NO. 15-154**

1 **WHEREAS, the Tohono O'odham Legislative Council approved the Agriculture Extension**  
2 **(BIA) Program FY 2015 Budget through Resolution No. 14-348 in the amount of**  
3 **\$155,751.37; and**

4 **WHEREAS, the Nation's Grants and Contracts Office has identified FY 2014 carry forward**  
5 **savings in the amount of \$155,878.61; and**

6 **WHEREAS, the Agriculture Extension Program is requesting that the FY 2014 carry forward**  
7 **savings in the amount of \$26,197.43 be added to the FY 2015 Agriculture**  
8 **Extension Program Budget and the remaining funds of \$129,681.18 will be**  
9 **allocated to the Range Conservation and Management FY 2015 Budget; and**

10 **WHEREAS, the Agriculture Extension Program has prepared budget Amendment No. 1**  
11 **increasing Operational Expense line items and budget amount; and**

12 **WHEREAS, the Agricultural and Natural Resources and the Budget and Finance Committees**  
13 **of the Legislative Council have reviewed this Budget and recommend its**  
14 **approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
16 **approved Amendment No. 1:**

- 17 **1. Approve utilizing carry forward savings in the amount of \$26,197.43 to be**  
18 **added to the Agriculture Extension FY 15 Budget.**
- 19 **2. Approve increasing Operational Expense line items.**
- 20 **3. Approve the Agriculture Extension base budget amount to \$165,422.50 and**  
21 **increasing indirect costs to \$18,128.48 for a revised total budget of**  
22 **\$183,550.98.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham legislative council hereby authorizes the**  
24 **Chairperson and any designated official to expend and administer the budget as**  
25 **attached, provided that any amendments affecting the funds or funding levels of**  
26 **the budget shall be submitted for further prior approval by the Tohono O'odham**  
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07<sup>TH</sup>**  
29 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
30 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
31 **Article VI, Section 1(d)(3) Section 1(f) of the Constitution of the Tohono O'odham Nation,**  
32 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
33 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
34 **16 of the Act of June 18, 1934 (48 Stat.984).**


