

LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Recessing May 8, 2015 General Session until Tuesday, May 12, 2015)

LEGISLATIVE ORDER NO. 15-156

1 WHEREAS, the Legislative Council is vested with the power "to establish rules and procedures
2 to regulate all meetings of the Tohono O'odham Council, standing committees,
3 boards and special committees" (Constitution of the Tohono O'odham Nation,
4 Article VI, Section 1(a)); and

5 WHEREAS, Article I, Section 1(B)(2) of the Legislative Rules of the Tohono O'odham
6 Legislative Council provides that a monthly general session of the Tohono
7 O'odham Legislative Council shall be held on dates specified in the legislative
8 calendar adopted by the Legislative Council; and

9 WHEREAS, a request has been made to recess the Friday, May 8, 2015 general session for the
10 services of Representative Frances Stephens *bad* and that session shall continue
11 if necessary on Tuesday, May 12, 2015.

12 NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that the May 8,

17 Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
18 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
19 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934
