

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2015 West Valley Tohono O'odham Nation Police Budget)**

RESOLUTION NO. 15-159

1 **WHEREAS, the Tohono O'odham Nation has begun the process of building and establishing**
2 **the new West Valley Casino and Resort; and**

3 **WHEREAS, the West Valley Casino and Resort will need Law Enforcement services to be**
4 **provided for the safety and well-being of its employees and visitors; and**

5 **WHEREAS, the Tohono O'odham Nation has provided funds to establish a Law Enforcement**
6 **Division for the West Valley Casino and Resort; and**

7 **WHEREAS, the Tohono O'odham Nation Police Department FY 2015 budget was reviewed by**
8 **the Executive Office, the Domestic Affairs and the Budget and Finance**
9 **Committees of the Legislative Council and recommends its approval.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
11 **approves the FY 2015 Tohono O'odham Nation Police West Valley Resort budget**
12 **in the amount of \$2,500,607.16 to be appropriated from the general fund.**

13 **BE IT FURTHER RESOLVED that the general fund shall be reimbursed this amount from the**
14 **Judgment Funds as approved by Resolution 15-127.**

15 **BE IT FURTHER RESOLVED that the Tohono O'odham Nation Police West Valley Resort budget**
16 **that any funds unexpended will automatically be forwarded to the next budget**
17 **year and the Police Department will seek additional funds for the continuation**
18 **of the operation.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
20 **the Chairperson and any designated official to expend and administer the**
21 **budget as attached, provided that any amendments affecting the funds or**
22 **funding level shall be submitted for further prior approval by the Tohono**
23 **O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH**
25 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,031.0 FOR; 895.9**
26 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
30 **June 18, 1934 (48 Stat.984).**
