


**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Revenue Projections of the Nation in the Amount of \$73,704,604.00)**

RESOLUTION NO. 15-164

1 **WHEREAS, the Tohono O'odham Legislative Council is vested with the power "to manage**
2 **any funds within the exclusive control of the Tohono O'odham Nation"**
3 **(Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2)); and**
4 **WHEREAS, the Legislative Budget and Finance Committee and the Executive Office**
5 **reviewed the revenue projections for FY 2016; and**
6 **WHEREAS, the Legislative Council approved the amending of Subsections 1301 of 26 Tohono**
7 **O'odham Code Chapter 1, Article 3 - Gaming Revenue Distribution Formula and**
8 **District Allocation Guidelines through Fiscal Year 2017 per resolution 14-345;**
9 **and**
10 **WHEREAS, the Nation's Treasurer has calculated that \$73,704,604.00 is needed to fund the**
11 **Nation's FY 2016 General Fund budgets for the Executive, Legislative and**
12 **Judicial Branches; and**
13 **WHEREAS, the Budget and Finance Committee, and the Executive Office recommend the**
14 **adoption of the FY 2016 revenue projections in the amount of \$73,704,604.00 to**
15 **fund the FY2016 General Fund Budgets per the attached FY 2016 Revenue**
16 **Projections.**
17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
18 **approves the FY 2016 revenue projections in the amount of \$73,704,604.00 for**
19 **the purpose of funding the FY 2016 General Fund budgets of the Tohono**
20 **O'odham Nation.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 18TH**
22 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
24 **Article VI, Section 1(d) and of the Constitution of the Tohono O'odham Nation, adopted by the**
25 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
26 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
27 **June 18, 1934 (48 Stat.984).**


