

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Legislative Branch FY 2016 Budget)

RESOLUTION NO. 15-166

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council**
2 **with the authority "to manage any funds within the exclusive control of the**
3 **Tohono O'odham Nation...and to appropriate these funds for the benefit of the**
4 **Nation and its members "provided that" [a]ll expenditures of these funds shall**
5 **be pursuant to appropriations or budgets" authorized by resolution or**
6 **ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section**
7 **1(d)(2)); and**

8 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval its**
9 **FY 2016 Legislative Branch Budget, which is incorporated by this reference; and**

10 **WHEREAS, the Legislative Branch distributed a courtesy copy of the FY 2016 Legislative**
11 **Branch Budget to all Councilmembers, Staff and all Districts; and**


12 **WHEREAS, the FY 2016 proposed budget was presented & reviewed by Budget and Finance**
13 **Committee of the Legislative Council have reviewed this budget and recommend**
14 **its approval and adoption.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **approves and authorizes expenditure of the FY 2016 Legislative Branch Budget**
17 **in the amount of \$3,318,850.13, as per the attached budget, beginning October 1,**
18 **2015 and ending September 30, 2016.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding level is**
22 **submitted for further prior approval by the Tohono O'odham Legislative**
23 **Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH**
25 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
26 **AGAINST; [01] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
30 **June 18, 1934 (48 Stat.984).**
