

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2016 Department of Health & Human Services/Indian Health
Service Budgets)**

RESOLUTION NO. 15-168

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from**
2 **the Indian Health Service; and**

3 **WHEREAS, the Executive Branch has approved and presented the FY 2016 TODHHS/IHS**
4 **Budgets, to be effective October 1, 2015 through September 30, 2016 and**
5 **requests authorization to expend the funds listed below; and**

6 **WHEREAS, the Nation has identified prior year savings associated with various programs**
7 **funded from the Indian Health Service Master contract and has developed**
8 **Budgets proposing to carry forward these savings in FY 2016, as listed below; and**

9 **WHEREAS, the Health and Human Service Committee and the Budget and Finance**
10 **Committee of the Legislative Council have reviewed these budgets and**
11 **recommend their approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **approves the budgets presented below, and authorizes the Executive Branch to**
14 **expend funds for the programs listed herein and as attached in the amount**
15 **indicated effective October 1, 2015 ending September 30, 2016:**

23 **federal Continuing Resolution, the programs shall limit spending to only**
24 **essential Program services, functions and activities, and the Nation shall seek**
25 **reimbursement of all funds the Nation expends for continuation of TODHHS**
26 **Programs performed pursuant to the P.L. 93-638 contract.**

27 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the**
28 **proposed carry forward of identified savings as presented in the program**
29 **Budgets listed below and authorizes the programs to expend funds as budgeted:**

BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham Nation's Chairman, is authorized to negotiate and execute the Indian Health Service FY 2016 Annual Funding Agreement with the Indian Health Service.

BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the Chairperson and any designated official to expend and administer the budgets as attached, provided that any amendments affecting the funds or funding level is submitted for further prior approval by the Tohono O'odham Legislative Council.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(d)(3) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
