

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving and Appropriating Funds for the Tohono O'odham Judicial Branch
FY 2016 Budget)**

RESOLUTION NO. 15-169

1 **WHEREAS, the Fiscal Year ("FY") 2015 will end at midnight, September 30, 2015 and all**
2 **spending authority granted under the FY 2015 budgets will terminate at that**
3 **time; and**

4 **WHEREAS, the Judicial Branch of the Tohono O'odham Nation has prepared and submitted**
5 **a budget to the Tohono O'odham Legislative Council ("Legislative Council") that**
6 **reflects the needs of the Branch for the 2016 fiscal year, in the amount of**
7 **\$5,835,586.12 a copy of the proposed budget is attached and incorporated by this**
8 **reference; and**

9 **WHEREAS, the Judiciary and the Budget and Finance Committees of the Legislative Council**
10 **have reviewed this budget and recommend its approval.**

11 **NOW, THEREFORE, BE IT RESOLVED the Tohono O'odham Legislative Council has reviewed and**
12 **approves the Fiscal Year 2016 budget for the Tohono O'odham Judicial Branch**
13 **in the amount of \$5,835,586.12.**

14 **BE IT FURTHER RESOLVED that funds in the amount of \$5,835,586.12 is appropriated from the**
15 **general funds and authorized to be expended for the Fiscal Year 2016 budget of**
16 **the Tohono O'odham Judicial Branch.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chief Judge and any designated official to expend and administer the Budget as**
19 **attached, provided that any amendments affecting the funds or funding level**
20 **shall be submitted for further prior approval by the Tohono O'odham**
21 **Legislative Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
23 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,422.6 FOR; 504.3**
24 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
28 **June 18, 1934 (48 Stat.984).**
