

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving FY 2016 Bureau of Indian Affairs Judicial Services Budget under the  
Nation's P.L. 93-638 Master Contract)**

**RESOLUTION NO. 15-170**

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from**  
2 **the Bureau of Indian Affairs under a P.L. 93-638 Master Contract; and**

3 **WHEREAS, in 2005, the Nation negotiated a P.L. 93-638 Master Contract with the Bureau of**  
4 **Indian Affairs which remains in effect; and**

5 **WHEREAS, the Judicial Branch has developed the following Judicial Services budget funded**  
6 **by the BIA Master Contract effective October 1, 2015 through September 30, 2016**  
7 **and requests approval of the budget and authorization to expend the funds as**  
8 **listed below; and**

9 **WHEREAS, the Judiciary and the Budget and Finance Committees of the Legislative Council**  
10 **have reviewed this budget and recommend its approval.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
12 **the BIA P.L. 93-638 contract Judicial Services budget listed herein, subject to**  
13 **negotiation and execution of annual funding agreements with the Tohono**  
14 **O'odham Nation Chairman and the Bureau of Indian Affairs, and authorizes the**  
15 **Judicial Branch to expend funds as budgeted in the Base Allocation amount of**  
16 **\$381,141.00 with Indirect Cost at \$77,790.88 for a total budget of \$458,931.88.**

17 **BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that in the event of a**  
18 **federal Continuing Resolution, the Judicial Branch shall limit spending to only**  
19 **essential program services, functions and activities, and the Nation shall seek**  
20 **reimbursement of all funds the Nation expends for continuation of BIA Judicial**  
21 **Services performed pursuant to the Master Contract.**

22 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council hereby authorizes**  
23 **the Chief Judge and any designated official to expend and administer the budget**  
24 **as attached, provided that any amendments affecting the funds or funding**  
25 **levels shall be submitted for further prior approval by the Tohono O'odham**  
26 **Legislative Council.**

27 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono**  
28 **O'odham Nation's Chairman is authorized to negotiate and execute the FY 2016**  
29 **Annual Funding Agreement with Bureau of Indian Affairs.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>**  
31 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
32 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
33 **Article VI, Section 1(d)(3) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted**  
34 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
35 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
36 **Act of June 18, 1934 (48 Stat.984).**
