2 **held in the Nation's Desert Diamond Savings Account for the continued**
3 **administration of the requirements of Initiative IN-08-97, and any funds**
4 **unexpended be returned to the Desert Diamond Savings Account.**

5 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
6 **Chairperson and any designated official to expend and administer the budget as**
7 **attached, provided that any amendments affecting the funds or funding level**
8 **shall be submitted for further prior approval by the Tohono O'odham Legislative**
9 **Council.**

10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
11 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
12 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
13 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
14 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
16 **June 18, 1934 (48 Stat.984).**
