

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2016 Department of Health and Human Services Title IV-B,
Subparts 1 & 2 Budgets for Division of Child Welfare; and Approving
the 10% Indirect Cost Rate for Title IV-B Budgets)

RESOLUTION NO. 15-172

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from**
2 **the Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a**
4 **Division of Child Welfare Services to intervene against child abuse and neglect**
5 **and to promote safe and stable families; and**

6 **WHEREAS, the Title IV-B, Subparts 1 & 2 grants require a 25% match, which the Nation**
7 **matches through the P.L. 93-638 master contract, specifically the BIA Social**
8 **Services budget for child welfare services and the BIA ICWA budget for Family**
9 **Preservation Program, as authorized by both P.L. 93- 638 and the Department of**
10 **Health and Human Services; and**

11 **WHEREAS, these Title IV-B, Subparts 1 & 2 Budgets are authorized for only a two year**
12 **expenditure period, beginning October 1, 2015 and ending September 30, 2017,**
13 **funding only the two fiscal years of FY 2016 and FY 2017; and**

14 **WHEREAS, the Department of Health and Human Services has provided estimated**
15 **allocation amounts for these budgets as:**

16 **1. \$89,367.00 for Title IV-B, Subpart 1 Budget**

17 **2. \$189,508.00 for Title IV-B, Subpart 2 Budget; and**

18 **WHEREAS, the U.S. Department of Health and Human Services, Administration for Children**
19 **and Families (ACF), has notified the Department that The Child and Family**
20 **Services Improvement Act of 2006 (Public Law 109-288) restricts administrative**
21 **costs to 10% starting October 1, 2007 for these Title IV-B budgets, and the**
22 **Department requests approval to submit these budgets with the following**
23 **restricted 10% amount for indirect costs; and**

24 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
25 **Legislative Council have reviewed this budget and recommend its approval.**

26 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
27 **approve and authorize the Executive Branch to expend funds and to utilize the**
28 **Nation's resources pending reimbursement from the Grantor for the**
29 **continuation of this Grant for the budgets attached in the following amounts:**

30 **1. FY16 Title IV-B, Subpart 1 Budget \$89,367.00.**

31 **2. FY16 Title IV-B, Subpart 2 Budget \$189,508.00.**

1 **BE IT FURTHER RESOLVED** that the Executive Branch is authorized to restrict the Indirect Cost
2 to 10% in Title IV-B budgets as required by The Child and Family Services
3 Improvement Act of 2006 (Public Law 109-288).

4 **BE IT FURTHER RESOLVED** that the Title IV-B Subparts 1 and 2 Budgets are authorized to
5 utilize funding for the two-year project period ending September 30, 2017 or
6 until the grant funds are fully expended to provide continued services.

7 **BE IT FINALLY RESOLVED** that the Tohono O'odham Nation Legislative Council hereby
8 Authorizes Chairman and any designated official to expend and administer the
9 budget as attached, provided that any budget amendments affecting the funds
10 or funding levels shall be submitted for further prior approval by the Tohono
11 O'odham Legislative Council.

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
13 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
14 **AGAINST; [01] NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
15 **Article VI, Section 1(c)(2) and (j) of the Constitution of the Tohono O'odham Nation, adopted by**
16 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
17 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
18 **June 18, 1934 (48 Stat.984).**


