

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of the FY 2016 Department of Health and Human Services - Division
of Health Transportation Service Budget, combining General Fund
Dollars and Program Revenue Dollars)**

RESOLUTION NO. 15-173

1 **WHEREAS, the Tohono O'odham Nation continues to provide non-emergency medically**
2 **necessary transportation to members and residents of the Nation, and**
3 **collecting third party reimbursements where applicable; and**

4 **WHEREAS, the Tohono O'odham Legislative Council Resolution No. 99-228 approved for the**
5 **establishment of a special revenue Account for third-party billing and**
6 **collection; and**

7 **WHEREAS, Division of Health Transportation Service has prepared a budget combining**
8 **program revenue dollars and general fund dollars for better budget**
9 **management; and**

10 **WHEREAS, the Health and Human Services and Budget and Finance Committees of the**
11 **Legislative Council have reviewed the budget and recommend its approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **authorizes the expenditure in the amount of \$3,641,979.06, a combination of**
14 **\$1,758,717.80 from program revenue dollars and \$1,883,261.26 from the general**
15 **fund per Resolution #15-165 for the budget period of October 1, 2015 -**
16 **September 30, 2016.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the budget as**
19 **attached, provided that any amendments affecting the funds or funding level is**
20 **submitted for further prior approval by the Tohono O'odham Legislative**
21 **Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
23 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,752.70 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and 174.2[04] ABSENT, pursuant to the powers vested in the Council**
25 **by Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
28 **June 18, 1934 (48 Stat.984).**


