

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Special Diabetes Program for Indians (SDPI) Grant for the Healthy**  
**O'odham Promotion Program for FY2016)**

RESOLUTION NO. 15-174

1 **WHEREAS, the Tohono O'odham Nation received a Special Diabetes Program for Indians**  
2 **(SDPI) grant funded by the Indian Health Service, Division of Diabetes**  
3 **Treatment and Prevention, with a base budget of \$1,785,580.00; and**

4 **WHEREAS, by Resolution Number 99-149, the Tohono O'odham Legislative Council**  
5 **approved the establishment of the Community Based Diabetes Prevention**  
6 **Program, funded by the Special Diabetes Program for Indians, authorized by the**  
7 **Balanced Budget Act of 1997; and**

8 **WHEREAS, the Tohono O'odham Department of Health & Human Services, Division of**  
9 **Healthy O'odham Promotion Program (HOPP) is requesting approval of the base**  
10 **FY 2016 budget in the amount of \$1,785,580.00, for a period of October 1, 2015 to**  
11 **September 30, 2016; and**

12 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**  
13 **Legislative Council have reviewed this budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
15 **approve the attached budget and authorizes the expenditure of funds according**  
16 **to this budget in the amount of \$1,785,580.00 and to utilize the Nation's**  
17 **resources pending reimbursement from the Grantor for the continuation of this**  
18 **Grant.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairman and any designated official to expend and administer the budget, as**  
21 **attached, provided that any amendments affecting the funds or funding level**  
22 **shall be submitted for further prior approval by the Tohono O'odham**  
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>th</sup>**  
25 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926,9 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Section 1(d)(2) of the Constitution of the Tohono O'odham Nation, adopted by the**  
28 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
30 **June 18, 1934 (48 Stat.984).**
