

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY2016 Arizona Long Term Care Services (ALTCS) Budget**  
**October 1, 2015 to September 30, 2016)**

**RESOLUTION NO. 15-175**

1 **WHEREAS, the Tohono O'odham Nation has an Intergovernmental Agreement with the State**  
2 **of Arizona to provide Arizona Long Term Care Services (ALTCS) Case**  
3 **Management services to eligible enrolled members; and**

4 **WHEREAS, the Tohono O'odham Nation has provided ALTCS case management services**  
5 **since June 1996 and is compensated from the State of Arizona for the services;**  
6 **and**

7 **WHEREAS, the Arizona Long Term Care Services (ALTCS) FY 2016 budget of \$547,887.00 has**  
8 **been prepared to continue to provide medical case management, homemaker**  
9 **services, personal care, attendant care, respite care and nursing care services to**  
10 **eligible Tohono O'odham Nation members who reside on or near the**  
11 **boundaries of the reservation; and**

12 **WHEREAS, all future ALTCS Program client compensated funds received by the Division of**  
13 **Senior Services shall be applied to the ALTCS base budget for current and future**  
14 **program operations; and**

15 **WHEREAS, the Health and Human Services and Budget and Finance Committees of the**  
16 **Legislative Council has reviewed this budget and recommends its approval.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
18 **approves: The Arizona Long Term Care Services (ALTCS) FY2016 budget of**  
19 **\$547,887.00 prepared to continue to provide medical case management,**  
20 **homemaker services, personal care, attendant care, respite care and nursing**  
21 **care services to eligible Tohono O'odham Nation members who reside on or**  
22 **near the boundaries of the reservation and to utilize the Nation's resources**  
23 **pending reimbursement from the Grantor for the continuation of this grant;**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
25 **Chairperson and any designated official to expend and administer the budget as**  
26 **attached, provided that any amendments affecting the funds or funding level**  
27 **shall be submitted for further prior approval by the Tohono O'odham**  
28 **Legislative Council.**

29 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>**  
30 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
31 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
32 **Article VI, Section 1(d)(2)(3) and 1(f) of the Constitution of the Tohono O'odham Nation,**  
33 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**  
34 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**  
35 **16 of the Act of June 18, 1934 (48 Stat.984).**
