**Advocacy Budgets, July 1, 2015 through June 30, 2016)**

**RESOLUTION NO. 15-176**

1 **WHEREAS, the Tohono O'odham Nation has successfully operated the Senior Services**  
2 **program for the Elders of the Nation; and**

3 **WHEREAS, funding for period July 1, 2015 through June 30, 2016 for the operation of the**  
4 **Senior Services Program is possible in part by Title III of the Older Americans**  
5 **Act funds administered through the Inter-Tribal Council of Arizona (ITCA); and**

6 **WHEREAS, the funding is necessary to continue Nutrition, Socialization, Transportation,**  
7 **Home Delivered Meal and Caregiver Support Services for eligible Elders; and**

8 **WHEREAS, the Title III-B \$41,767.00; Title III C-1 \$45,558.00; Title III C-2 \$28,454.00 program**  
9 **FY2016 budgets have been prepared for Nutrition, Socialization, Transportation**  
10 **and Home Delivered Meal services for eligible Elders; and**

11 **WHEREAS, a 10% In-kind match is required for Meals and Transportation and contributed**  
12 **from the Tohono O'odham Nation's Senior Services Tribal budget salaries line**  
13 **item; and**

14 **WHEREAS, the Title III E FY2016 budget of \$20,281.00 will provide support services to**  
15 **current and potential Caregivers who provide care services for Elders and to**  
16 **Elders who care for grandchildren; and**

17 **WHEREAS, the Title VII Long Term Care Services (LTCS) Advocacy FY2016 budget of**  
18 **\$10,000.00 has been prepared to support the certified Ombudsman staff,**  
19 **specially trained advocate who seeks to resolve complaints on behalf of**  
20 **residents of long term care facilities; including assistant living and skilled**  
21 **nursing facilities; and**

22 **WHEREAS, the Health and Human Services and Budget and Finance Committees of the**  
23 **Legislative Council has reviewed these budgets and recommends their approval.**

24 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
25 **approves:**

- 26 1. **The Title III-B \$41,767.00; Title III C-1 \$45,558.00; Title III C-2 \$28,454.00**  
27 **program FY 2016 budgets for the Nutrition, Socialization, Transportation**  
28 **and Home Delivered Meal services for eligible Elders.**
- 29 2. **The In-Kind Match of 10% for Meals and Transportation contributed from**  
30 **the Senior Services Tribal Budget salaries line item.**
- 31 3. **The Title III E \$20,281.00 FY 2016 budget for support services to current**  
32 **and potential Caregivers who provide care services for Elders and to**  
33 **Elders who care for grandchildren.**

9                                   **Chairperson and any designated official to expend and administer the budget as**  
10                                  **attached, provided that any amendments affecting the funds or funding level is**  
11                                  **submitted for further prior approval by the Tohono O'odham Legislative**  
12                                  **Council.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>**  
14 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
15 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
16 **Article VI, Section 1(d)(2)(3)and(f) of the Constitution of the Tohono O'odham Nation, adopted**  
17 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
18 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
19 **Act of June 18, 1934 (48 Stat.984).**
