RESOLUTION NO. 15-178

1 **WHEREAS, the Tohono O'odham Nation submitted an application for funding under the**
2 **U.S. Department of Health and Human Services for Enhancing HIV/AIDS**
3 **Screening and Patient Navigation Project in the amount of \$83,000.00 for a five**
4 **year period from September 30, 2013 through August 31, 2018; and**

5 **WHEREAS, the Nation was informed it was awarded and received Notice of Award dated**
6 **September 27, 2013 for an amount of \$28,108.00 for the first year funding and**
7 **also designated a grant project period from September 30, 2013 through August**
8 **31, 2018, to complete the HIV/AIDS screening and patient navigation project;**
9 **and**

10 **WHEREAS, a budget of \$28,108.00 has been prepared for Fiscal Year 2016 from October 1,**
11 **2015 through September 30, 2016; and**

12 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
13 **Legislative Council have reviewed this budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
15 **approves the U.S. Department of Health and Human Services, Indian Health**
16 **Service Office on Grant Management (OGM), Enhancing HIV/AIDS Screening and**
17 **Patient Navigation Project Award No. D921IHS0010-01-00 FY 2016, for the budget**
18 **period of October 1, 2015 through September 30, 2016, budget in the amount of**
19 **\$28,108.00 for the third year award for Enhancing HIV/AIDS Screening and**
20 **Patient Navigation Project and to utilize the Nation's Resources pending**
21 **reimbursement from the Grantor for the continuation of the Grant.**

22 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
23 **Chairperson and any designated official to expend and administer the budget as**
24 **attached, provided that any Amendments affecting the funds or funding level is**
25 **submitted for further prior approval by the Tohono O'odham Legislative**
26 **Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
28 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
29 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
30 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
31 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
33 **June 18, 1934 (48 Stat.984).**
