1 **WHEREAS, the Tohono O'odham Nation successfully applied for and was awarded a five**
2 **year Grant from the U.S. Department of Health and Human Services, Centers for**
3 **Disease Control and Prevention (CDC) grant period June 30, 2012 – June 29, 2017;**
4 **and**

5 **WHEREAS, the U.S. Department of Health and Human Services Centers for Disease Control**
6 **and Prevention (CDC) issued a Notice of Award on July 03, 2012 awarding grant**
7 **funding for the period covering June 30, 2012 through June 29, 2017, subject to**
8 **the availability of funds and satisfactory progress; and**

9 **WHEREAS, the Tohono O'odham Comprehensive Cancer Prevention and Control Planning**
10 **grant has submitted the FY 2016 Budget in the amount of \$197,919.00; and**

11 **WHEREAS, the Health and Human Services and Budget and Finance Committees have**
12 **reviewed the attached FY 2016 Cancer Budget and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
14 **FY 2016 Comprehensive Cancer Prevention and Control Planning Grant budget**
15 **in the amount of \$197,919.00 for the period covering June 30, 2015 through June**
16 **29, 2016.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the Budget as**
19 **attached, provided that any Amendments affecting the funds or funding level is**
20 **submitted for further prior approval by the Tohono O'odham Legislative**
21 **Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
23 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
26 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
28 **June 18, 1934 (48 Stat.984).**
