

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family
Assistance – FY 2016 Food Distribution Program Budget)

RESOLUTION NO. 15-180

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY 2016 grant with the**
3 **United States Department of Agriculture (USDA); and**

4 **WHEREAS, the grant requires a 25% match which is contributed by the Tohono O'odham**
5 **Nation's Food Distribution Tribal budget; and**

6 **WHEREAS, such tribal operations have been successful and beneficial to the Tohono**
7 **O'odham Nation and the people; and**

8 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to apply for FY 2016**
9 **United States Department of Agriculture funds to assist eligible individuals and**
10 **families with commodity foods; and**

11 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
12 **Legislative Council have reviewed this budget and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
14 **and authorizes the FY2016 Food Distribution Program budget in the amount of**
15 **\$244,714.00 in accordance with the attached budget and 25% match**
16 **contribution from the Food Distribution Tribal budget and to utilize the**
17 **Nation's resources pending reimbursement from the Grantor for the**
18 **continuation of this Grant.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding level**
22 **shall be submitted for further prior approval by the Tohono O'odham**
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
25 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; ~~0~~**
26 **AGAINST; ~~0~~ NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Section 1(d)(2)(3)and1(f) of the Constitution of the Tohono O'odham Nation, adopted**
28 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
30 **Act of June 18, 1934 (48 Stat.984).**
