

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Department of Health and Human Services, Division of Family Assistance
- FY 2016 Food Distribution Program Nutrition Education Funding Budget)

RESOLUTION NO. 15-181

1 **WHEREAS, the Department of Health and Human Services is presently operating the Family**
2 **Assistance Division, Food Distribution Program under an FY 2016 grant with the**
3 **United States Department of Agriculture (USDA); and**

4 **WHEREAS, the Food Distribution Program has been beneficial in providing food packages**
5 **(commodity foods) and nutrition education to eligible households through**
6 **tailgate runs throughout the Nation and nearby towns; and**

7 **WHEREAS, nutrition education funds have been made available to the Tohono O'odham**
8 **Nation for FY2016 through the USDA in the amount of \$1,910.00; and**

9 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
10 **Legislative Council have reviewed this budget and recommend its approval.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**
12 **the expenditure of the FY 2016 Food Distribution Nutrition Education budget in**
13 **the amount of \$1,910.00 in accordance with the attached budget and to utilize**
14 **the Nation's resources pending reimbursement from the Grantor for the**
15 **continuation of the Grant.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairperson and any designated official to expend and administer the budget as**
18 **attached, provided that any amendments affecting the funds or funding level**
19 **shall be submitted for further prior approval by the Tohono O'odham**
20 **Legislative Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
22 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
24 **Article VI, Section 1(d)(2)(3) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted**
25 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
26 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
27 **Act of June 18, 1934 (48 Stat.984).**
