

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Department of Health and Human Services - Division of Behavioral Health, Tas Tonlik Ki Program FY 2016 Third Party Revenue Budget)

RESOLUTION NO. 15-182

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health is**
2 **currently operating the Behavioral Health Division through an Indian Health**
3 **Services (I.H.S.) 638 Contract. The Tas Tonlik Ki Program (SMI) Program is a**
4 **comprehensive Day Treatment Program for Seriously Mentally Ill and**
5 **Developmental Disabled Adults, services which includes educational sessions**
6 **on general mental health and substance abuse, community activities, work**
7 **projects, and case management. The original SMI funds from the I.H.S. grant**
8 **ended on August 31, 1990; and**

9 **WHEREAS, pursuant to Legislative Council Resolution No. 99-500, the Department of Health**
10 **and Human Services, Division of Behavioral Health, Tas Tonlik Ki Program has**
11 **been collecting third party reimbursement funds since September 1999 from**
12 **the State of Arizona and has since accumulated funds; and**

13 **WHEREAS, the Tas Tonlik Ki Program has accumulated funds to cover the Third Party**
14 **Revenue Budget in the amount of \$959,500.00 for FY 2016 personnel, operational**
15 **and capital expenses; and**

16 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
17 **Legislative Council have reviewed this budget and recommend its approval.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council approves the**
19 **attached FY 2016 Tas Tonlik Ki Program Third Party Revenue Budget in the**
20 **amount of \$959,500.00 to supplement the FY 2016 Department of Health and**
21 **Human Services, Division of Behavioral Health Budget and is hereby approved**
22 **to expend such funds.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the budget as**
25 **attached, provided that any amendments affecting the funds or funding level is**
26 **submitted for further prior approval by the Tohono O'odham Legislative**
27 **Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
29 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2)and1(f) of the Constitution of the Tohono O'odham Nation, adopted by**
32 **the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
34 **June 18, 1934 (48 Stat.984).**
