RESOLUTION NO. 15-183

1 **WHEREAS, the Tohono O'odham Nation has successfully operated the Women, Infants, and**
2 **Children (WIC) Program under the oversight of the Tohono O'odham**
3 **Department of Health and Human Services-Division of Community Health**
4 **Services; and**

5 **WHEREAS, the WIC Program provides services to prevent health problems and improve the**
6 **health of clients during critical times of growth and development; and**

7 **WHEREAS, the services provided to eligible clients have been beneficial and services**
8 **continue to be necessary to help alleviate nutritional health risks and improve**
9 **the health of individuals at risk; and**

10 **WHEREAS, the Tohono O'odham Nation has entered into a Memorandum of Agreement with**
11 **the Inter-Tribal Council of Arizona to fund and operate the Women Infants and**
12 **Children (WIC) Program which commenced on October 01, 2014 through**
13 **September 30, 2016; and**

14 **WHEREAS, the Inter Tribal Council of Arizona assigned caseload is 950 per month and grant**
15 **level is \$200,411.00 for the Women, Infants and Children (WIC) program effective**
16 **October 1, 2015 through September 30, 2016; and**

17 **WHEREAS, the Women, Infants, and Children (WIC) has submitted the FY 2016 WIC Budget**
18 **in the amount of \$200,411.00; and**

19 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**
20 **Legislative Council have reviewed this Budget and recommend its approval.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
22 **approve and authorize expenditures of the FY 2016 attached budget in the**
23 **amount of \$200,411.00 from the Inter-Tribal Council of Arizona to continue**
24 **program operation and continue provided services to eligible women, infants**
25 **and children and to utilize the Nation's resources pending reimbursement from**
26 **the Grantor for the continuation of this grant.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
28 **Chairperson and any designated official to expend and administer the budget as**
29 **attached, provided that any amendments affecting the funds or funding level is**
30 **submitted for further prior approval by the Tohono O'odham Legislative**
31 **Council.**
