**RESOLUTION NO. 15-184**

1 **WHEREAS, the B.I.A. P.L. 102-477 Master Contract budget funds combined federal programs**  
2 **under the Education Department - One Stop Division from October 1, 2015 to**  
3 **September 30, 2016 with projected allocations in the amount of \$1,223,708.72;**  
4 **and**

5 **WHEREAS, the B.I.A. P.L. 102-477 Master Contract budget had been developed and cost**  
6 **shared with the Arizona Department of Economic Security funding to promote**  
7 **transitional services for clients with an effective cost share to promote**  
8 **decentralized services; and**

9 **WHEREAS, the B.I.A. P.L. 102-477 Master Contract budget will be modified when federal**  
10 **allocations have been received to reflect the actual allocations; and**

11 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**  
12 **the Legislative Council have reviewed this Budget and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
14 **approves and authorizes the expenditure of the FY 2016 B.I.A. P.L. 102-477**  
15 **Master Contract budget for the Education Department - One Stop Division**  
16 **effective October 1, 2015 to September 30, 2016 in the projected amount of**  
17 **\$1,223,708.72.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
19 **Chairperson and any designated official to expend and administer the Budget as**  
20 **attached, provided that any Amendments affecting the funds or funding level is**  
21 **submitted for further prior approval by the Tohono O'odham Legislative**  
22 **Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>**  
24 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
25 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**  
26 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**  
27 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**  
29 **June 18, 1934 (48 Stat.984).**
