

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Department of Health and Human Services Child Care and
Development Fund Mandatory & Discretionary Budgets)**

RESOLUTION NO. 15-185

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from**
2 **the Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating**
4 **Child Care Services to provide child care services to its young tribal members;**
5 **and**

6 **WHEREAS, the Department of Health and Human Services awards the project period for**
7 **two-years beginning October 1, 2015 and ending September 30, 2017 and Child**
8 **Care Services has prepared Child Care and Development Fund Budgets as**
9 **outlined below:**

- 10 **1. FY 2016 CCDF Mandatory Funds - \$413,462.00.**
- 11 **2. FY 2016 CCDF Discretionary Funds - \$284,323.00; and**

12 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**
13 **the Legislative Council have reviewed the FY 2016 budgets and recommend their**
14 **approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **approves the FY 2016 CCDF Mandatory Budget of \$413,462.00, and FY 2016 CCDF**
17 **Discretionary Budget in the amount of \$284,323.00 and to utilize the Nation's**
18 **resources pending reimbursement from the Grantor for the continued funding**
19 **of the Grant.**

20 **BE IT FURTHER RESOLVED that the Child Care and Development Fund budgets are authorized**
21 **to utilize funding for the two-year project period ending September 30, 2017 or**
22 **until the grant funds are fully expended to provide continued services.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the Budgets**
25 **as attached, provided that any Amendments affecting the funds or funding**
26 **levels is submitted for further prior approval by the Tohono O'odham**
27 **Legislative Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
29 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(d)(2)(3)and1(f) of the Constitution of the Tohono O'odham Nation, adopted**
32 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
33 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
34 **Act of June 18, 1934 (48 Stat.984).**
