4		Head Start Program to provide educational, health, mental health and parent
5		involvement services to children, three to five years of age; and
6	WHEREAS,	the Administrative Cost is restricted to 15% of the total Non Federal and Federal
7		Share of funding for the Head Start Program; and
8	WHEREAS,	the indirect cost is inclusive of the restriction, thereby budgeted in the
9		Administration Budget only; and
10	WHEREAS,	the Human Resource Development Committee and the Budget and Finance
11		Committee of the Legislative Council have reviewed these Budgets and
12		recommend their approval.
13	NOW, THER	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
14		accepts and approves the program budgets listed below effective November 1,
15		2015 through October 31, 2016 for a total amount of \$1,761,428.00.
16		1. FY 2016 Head Start Administration Budget - \$317,057.00.
17		2. FY 2016 Head Start Program Budget - \$1,421,166.00.
18		3. FY 2016 Head Start T&TA Budget - \$23,205.00.
19		4. Restrict Administrative Costs to 15% of the total Non Federal and Federal
20		Share of funding for the Head Start Program.
21		5. Utilize the Nation's Resources pending reimbursement from the Grantor
22		for the continuation of the grant.
