

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2016 Child and Adult Care Food Program)**

RESOLUTION NO. 15-187

1 **WHEREAS, the Tohono O'odham Nation has historically sought reimbursement through an**
2 **agreement from the State of Arizona; and**

3 **WHEREAS, the Arizona Department of Education through the Child and Adult Care Food**
4 **Program Service Agreement provided reimbursement of funds for food costs**
5 **incurred based on the guidelines identified in the agreements; and**

6 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**
7 **the Legislative Council have reviewed this Budget and recommend its approval.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
9 **approves the FY 2016 Child and Adult Care Food Program Budget in the amount**
10 **of \$85,491.10 effective October 1, 2015 through September 30, 2016 and to utilize**
11 **the Nation's resources pending reimbursement from the Grantor for the**
12 **continued funding of the Grant.**

13 **BE IT FURTHER RESOLVED that the Executive Branch will seek reimbursement from the**
14 **Arizona Department of Education through the Child and Adult Care Food**
15 **Program Services Agreement, to reimburse funds for food costs incurred based**
16 **on the guidelines identified in the agreement.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the Budget as**
19 **attached, provided that any Amendments affecting the funds or funding level is**
20 **submitted for further prior approval by the Tohono O'odham Legislative**
21 **Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
23 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1(d)(2)(3) and 1(f) of the Constitution of the Tohono O'odham Nation, adopted**
26 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
27 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
28 **Act of June 18, 1934 (48 Stat.984).**
