

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Planning and Economic Development Department's FY2016 Budget
for the Sells District Design and Construction of Street Signs and Lights
from the 2008 PLHD Discretionary Funds)**

RESOLUTION NO. 15-189

1 **WHEREAS, the Planning and Economic Development Department provides day to day**
2 **management of the Department's Roads Program, and presents to the Tohono**
3 **O'odham Legislative Council, for review and approval, the FY 2016 budget for the**
4 **Sells District Design and Construction of Street Signs and Lights; and**

5 **WHEREAS, the Sells District Design and Construction of Street Signs and Lights has been**
6 **funded in the amount of \$174,282.94 as part of the BIAWRO P.L. 93-638 Master**
7 **Contract; and**

8 **WHEREAS, BIAWRO P.L. 93-638 Contract #A10AV00192 has been reviewed and approved by**
9 **the Nation and contains the scope of work for the Sells District Design and**
10 **Construction of Street Signs and Lights; and**

11 **WHEREAS, the Planning and Economic Development Department will select a private civil**
12 **engineering consultant, registered in the State of Arizona, to perform the**
13 **second level reviews of the design on the construction documents for the Sells**
14 **District Street Signs and Lights Project; and**

15 **WHEREAS, the Agricultural and Natural Resources and the Budget and Finance Committees**
16 **of the Legislative Council have reviewed this Budget and recommend its**
17 **approval.**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
19 **approves the FY-2016 budget for the Sells District Design and Construction of**
20 **Street Signs and Lights Project in the amount of \$174,282.94 from the 2008 PLHD**
21 **Discretionary Funds referenced in BIAWRO P.L. 93-638 Contract to administer**
22 **the grant in accordance with the budget attached.**

23 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
24 **Chairperson and any designated official to expend and administer the budget as**
25 **attached, provided that any amendments affecting the funds or funding level is**
26 **submitted for further prior approval by the Tohono O'odham Legislative**
27 **Council.**

28 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH**
29 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
30 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
31 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
32 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
33 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
34 **June 18, 1934 (48 Stat.984).**
