

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2016 Budget for Bureau of Indian Affairs P.L. 93-638 Contract,
Transportation Planning & Roads Inventory Data Collection)

RESOLUTION NO. 15-191

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from**
2 **the Bureau of Indian Affairs under a P.L. 93-638 Contract; and**

3 **WHEREAS, modification #47 was issued under the previous Bureau of Indian Affairs**
4 **Contract No. CTH54T61076 in the amount of \$150,860.39 to incorporate a revised**
5 **scope of work to include modification/updating of Road Inventory Data, in Road**
6 **Inventory Field Data System (RIFDS) format, which has been submitted to date;**
7 **prepare a 20-year Long Range Transportation Plan; incorporate proposals and**
8 **Task Cost Summaries from two consultants (PTE and PAIKI) to complete the**
9 **additional work; and extend the performance period to September 30, 2008; and**

10 **WHEREAS, modification #0009 was issued to remove from the contract the cost proposals**
11 **and the task cost summaries submitted by the two consultants as well as an**
12 **extension of the performance period through September 30, 2016; and**

13 **WHEREAS, the Agricultural and Natural Resources and the Budget and Finance Committees**
14 **of the Legislative Council have reviewed this Budget and recommend its**
15 **approval.**

16 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
17 **approves the attached FY 2016 Budget in the amount of \$150,860.39 to**
18 **administer the grant in accordance with the budget attached.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding level is**
22 **submitted for further prior approval by the Tohono O'odham Legislative**
23 **Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20th**
25 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
27 **Article VI, Section 1(f) and 1(d)(3) of the Constitution of the Tohono O'odham Nation, adopted**
28 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
30 **Act of June 18, 1934 (48 Stat.984).**
