1 **WHEREAS, the Planning and Economic Development Department provides day to day**  
2 **management of the Department's Roads Program, and presents to the Tohono**  
3 **O'odham Legislative Council, for review and approval, the FY 2016 budget for the**  
4 **San Lucy Community design and construction of the sidewalks and street lights;**

6 **WHEREAS, the San Lucy Community design and construction of the sidewalks and street**  
7 **lights, has been funded in the amount of \$228,185.08 as part of the BIA WRO P.L.**  
8 **93-638 Master Contract, Modification #74; and**

9 **WHEREAS, the Planning and Economic Development Department Roads Program will**  
10 **provide the design for the San Lucy Community design and construction**  
11 **documents of sidewalks and street lights project; and**

12 **WHEREAS, the Planning and Economic Development Department will recommend a**  
13 **private civil engineering consultant, registered in the State of Arizona, to**  
14 **perform the second level reviews of the design on the construction documents**  
15 **for the San Lucy Community sidewalks and street lights project; and**

16 **WHEREAS, the Agricultural and Natural Resources and the Budget and Finance Committees**  
17 **of the Legislative Council have reviewed this Budget and recommend its**  
18 **approval.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
20 **approves the FY 2016 budget for the San Lucy Community design and**  
21 **construction of the sidewalks and street lights, in the amount of \$228,185.08**  
22 **from the 2008 PLHD Discretionary Funds referenced in BIA WRO P.L. 93-638**  
23 **Contract to administer the grant in accordance with the budget attached.**

24 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
25 **Chairperson and any designated official to expend and administer the Budget as**  
26 **attached, provided that any amendments affecting the funds or funding level is**  
27 **submitted for further prior approval by the Tohono O'odham Legislative**
