**RESOLUTION NO. 15-197**

1 **WHEREAS, the Tohono O'odham Nation was awarded an Environmental Protection Agency**  
2 **106 grant award, in the amount of \$135,000.00; and**

3 **WHEREAS, the Water Resources Department is requesting the authority to expend the 106**  
4 **grant award for the FY 2016 budget; and**

5 **WHEREAS, the Water Resources Department is requesting an in-kind service match of**  
6 **\$7,105.00 from the Water Resources Department FY2016 budget; and**

7 **WHEREAS, the Water Resources and the Budget and Finance Committees of the Legislative**  
8 **Council have reviewed this Budget and recommend its approval.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
10 **approves the budget for an Environmental Protection Agency 106 grant award,**  
11 **in the amount of \$135,000.00, and an in-kind service match of \$7,105.00 from the**  
12 **Water Resources Department FY2016 budget.**

13 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council approves the**  
14 **attached FY2016 budget which does not include Indirect Cost and authorizes the**  
15 **expenditure of funds for this budget from October 1, 2015 to September 30, 2016.**

16 **BE IT FURTHER RESOLVED that the Tohono O'odham Legislative Council authorizes the**  
17 **Chairperson or designee to seek reimbursement for any Indirect Cost expenses**  
18 **in the event an Indirect Cost Rate is subsequently approved by the National**  
19 **Business Center.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
21 **Chairperson and any designated official to expend and administer the Budget as**  
22 **attached, provided that any Amendments affecting the funds or funding level is**  
23 **submitted for further prior approval by the Tohono O'odham Legislative**  
24 **Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup>**  
26 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,752.7 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and 174.2[04] ABSENT, pursuant to the powers vested in the Council**  
28 **by Article VI, Section 1(d)(2)(3) and (f) and Article XVII of the Constitution of the Tohono**  
29 **O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved**  
30 **by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986,**  
31 **pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).**
