RESOLUTION NO. 15-198

1 **WHEREAS, the Water Resources Department is requesting \$1,801,956.77 from the Southern**
2 **Arizona Water Rights Settlement Act Trust Fund for the FY2016 budget; and**
3 **WHEREAS, the Water Resources Department is also requesting an in-kind service match of**
4 **\$7,105.00 from the FY2016 SAWRSA budget for the Water Resources Department**
5 **FY2016 EPA budget; and**
6 **WHEREAS, the Water Resources and the Budget and Finance Committees of the Legislative**
7 **Council have reviewed this Budget and recommend its approval.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
9 **authorizes:**

- 10 **1. the appropriation and expenditure of \$1,801,956.77 from the Southern**
11 **Arizona Water Rights Settlement Act Trust Fund for the Water Resources**
12 **Department FY2016 budget, in accordance with the budget attached**
13 **hereto; and**
- 14 **2. an in-kind service match of \$7,105.00 from the FY2016 SAWRSA budget to**
15 **the Water Resources Department FY2016 EPA budget.**

16 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
17 **Chairperson and any designated official to expend and administer the Budget,**
18 **as attached, provided that any Amendments affecting the funds or funding level**
19 **is submitted for further prior approval by the Tohono O'odham Legislative**
20 **Council.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
22 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
23 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
24 **Article VI, Section 1(f)(j) and Article XVII of the Constitution of the Tohono O'odham Nation,**
25 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
26 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
27 **16 of the Act of June 18, 1934 (48 Stat.984).**
