

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Acceptance of the GAP FY2016 Budget)

RESOLUTION NO. 15-199

1 **WHEREAS, the Tohono O'odham Nation is devoted to the goals of protecting the**
2 **environment and safe guarding the health and well-being of the Nation's**
3 **members; and**

4 **WHEREAS, the Tohono O'odham Nation has submitted a proposal to the U.S. Environmental**
5 **Protection Agency under the Indian General Assistance Program (GAP) in the**
6 **amount of \$380,651.88 for continued funding which will be awarded in**
7 **Assistance Agreement; and**

8 **WHEREAS, the GAP Grant is a 4-year continuation grant with a project period that shall**
9 **extend from October 1, 2014 through September 30, 2018 and will require**
10 **annual applications for new funding allocations; and**

11 **WHEREAS, this budget does not include IDC as the agency will not allow IDC to be charged**
12 **without a current year IDC agreement; and**

13 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees of the Legislative**
14 **Council have reviewed this FY 2016 Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
16 **accepts the FY 2016 Budget in the amount of \$380,651.88 which does not include**
17 **IDC and authorizes the expenditure of funds according to this budget which**
18 **shall be in effect from October 1, 2015 to September 30, 2016 and to utilize the**
19 **Nation's Resources pending reimbursement from the Grantor for the continued**
20 **funding of the grant.**

21 **BE IT FURTHER RESOLVED that the Legislative Council authorizes the Chairperson or their**
22 **designee to seek reimbursement or recoup any indirect cost expenses in the**
23 **event an indirect cost rate is subsequently approved by the National Business**
24 **Center**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
26 **Chairperson and any designated official to expend and administer the budget as**
27 **attached, provided that any Amendments affecting the funds or funding level**
28 **shall be submitted for further prior approval by the Tohono O'odham**
29 **Legislative Council.**

30 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
31 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
32 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
33 **Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the**
34 **Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
35 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of**
36 **June 18, 1934 (48 Stat.984).**
