

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Acceptance of the Brownfields Section 128(a) FY 2016 Budget)**

**RESOLUTION NO. 15-200**

1 **WHEREAS, the Tohono O'odham Nation is devoted to the goals of protecting the**  
2 **environment and safe guarding the health and well-being of the Nation's**  
3 **members; and**

4 **WHEREAS, the Tohono O'odham Nation has submitted a proposal to the U.S. Environmental**  
5 **Protection Agency under the Brownfields Section 128(a) Tribal Response**  
6 **Program in the amount of \$145,000.00 for continued funding which will be**  
7 **awarded in an Assistance Agreement; and**

8 **WHEREAS, the Brownfields Section 128(a) Grant would allow the Program to continue to**  
9 **identify, assess and conduct oversight at cleanup activities where**  
10 **contamination exists throughout the Nation; and**

11 **WHEREAS, this budget does not include IDC as the agency will not allow IDC to be charged**  
12 **without a current year IDC agreement; and**

13 **WHEREAS, the Domestic Affairs and the Budget and Finance Committees of the Legislative**  
14 **Council have reviewed this Budget and recommend its approval.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
16 **accepts the FY 2016 Budget in the amount of \$145,000.00 which does not include**  
17 **IDC and authorizes the expenditure of funds according to this budget which**  
18 **shall be in effect from October 1, 2015 to September 30, 2016 and to utilize the**  
19 **Nation's resources pending reimbursement from the Grantor for the continued**  
20 **funding of the grant budget.**

21 **BE IT FURTHER RESOLVED that the Legislative Council authorizes the Chairperson or their**  
22 **designee to seek reimbursement to recoup any indirect cost expenses in the**  
23 **event an indirect cost rate is subsequently approved by the National Business**  
24 **Center.**

25 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
26 **Chairperson and any designated official to expend and administer the budget as**  
27 **attached, provided that any amendments affecting the funds or funding level**  
28 **shall be submitted for further prior approval by the Tohono O'odham**  
29 **Legislative Council.**

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0- AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Article VI, Section 1(f) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat.984).
