# **RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL** (Acceptance of the Clean Air Act FY 2016 Budget)

### **RESOLUTION NO. 15-201**

1	WHEREAS,	the Tohono O'odham Nation is devoted to the goals of protecting the
2		environment and safe guarding the health and well-being of the Nation's
3		members; and
4	WHEREAS,	the Tohono O'odham Nation has submitted a proposal to the U.S. Environmental
5		Protection Agency under the Clean Air Act (CAA) Grant in the amount of
6		\$126,819.92 for continued funding which will be awarded in an Assistance
7		Agreement; and
8	WHEREAS,	the Clean Air Act grant would allow the Nation to update the Point Source
9		Emissions Inventory and Quality Assurance Project Plan, implement a
10		Monitoring Plan; conduct Air Toxic and Particulate Matter (PM10) Monitoring
11		and participation in local, regional and national initiatives; and
12	WHEREAS,	this budget does not include IDC as the agency will not allow IDC to be charged
13		without a current year IDC agreement; and
14	WHEREAS,	the Domestic Affairs and the Budget and Finance Committees of the Legislative
15		Council have reviewed this Budget and recommend its approval.
16	NOW, THERI	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
17		accepts the FY 2016 Budget in the amount of \$126,819.92 which does not include
18		IDC and authorizes the expenditure of funds according to this budget which
19		shall be in effect from October 1, 2015 to September 30, 2016 and to utilize the
20		Nation's resources pending reimbursement from the Grantor for the continued
21		funding of the grant.
22	BE IT FURTH	IER RESOLVED that the Legislative Council authorizes the Chairperson or their
23		designee to seek reimbursement or recoup any indirect cost expenses in the
24		event an indirect cost rate is subsequently approved by the National Business
25		Center.
26	BE IT FINALI	Y RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
27		Chairperson and any designated official to expend and administer the budget as
28		attached, provided that any amendments affecting the funds or funding level
29		shall be submitted for further prior approval by the Tohono O'odham
30		Legislative Council.
