

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Tohono O'odham Tribal Employment Rights Office FY 2016
TERO/EEOC Budget)

RESOLUTION NO. 15-202

1 **WHEREAS, the Tohono O'odham Nation has operated the Tribal Employment Rights Office**
2 **since 1978; and**

3 **WHEREAS, the continued operation of the Tribal Employment Rights Office is to increase**
4 **employment of Indians on and near the Tohono O'odham Nation by enforcing**
5 **Indian Preference in employment, training, contracting, subcontracting and**
6 **eradicate employment discrimination within the exterior boundaries of the**
7 **Tohono O'odham Nation; and**

8 **WHEREAS, the funding for the Tohono O'odham Nation Tribal Employment Rights Office**
9 **has been supplemented by the Equal Employment Opportunity Commission in**
10 **the amount of \$26,000.00; and**

11 **WHEREAS, the Human Resources Development and the Budget and Finance Committees of**
12 **the Legislative Council have reviewed this Budget and recommend its approval.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
14 **accepts the FY 2016 TERO/EEOC Budget in the amount of \$26,000.00 and to**
15 **utilize the Nation's resources pending reimbursement from the Grantor for the**
16 **continued funding of the contract.**

17 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
18 **Chairperson and any designated official to expend and administer the budget as**
19 **attached, provided that any amendments affecting the funds or funding level is**
20 **submitted for further prior approval by the Tohono O'odham Legislative**
21 **Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
23 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Article VI, Section 1(d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted**
26 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**
27 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**
28 **Act of June 18, 1934 (48 Stat.984).**
