RESOLUTION NO. 15-203

1	WHEREAS,	the Tohono O'odham Nation ("Nation") has a policy of consolidating lands within
2		the Nation into tribal ownership, as stated in the Constitution of the Tohono
3		O'odham Nation, Article XVI, Section 9, by acquiring lands, natural resources,
4		including minerals and water rights within or adjacent to its boundaries, or
5		which originally were a part of the historic Papagueria; and
6	WHEREAS,	the Constitution of the Tohono O'odham Nation, Article XVI, Section 10 directs
7		that a portion of the Nation's revenue from natural resources be dedicated to
8		reacquiring lands, natural resources, minerals and water rights; and
9	WHEREAS,	Resolution No. 2000-057 established the Land Acquisition Fund; and
10	WHEREAS,	beginning in Fiscal Year 2001, ten percent (10%) of the Nation's share of mining
11		proceeds were set aside and placed in the Land Acquisition Fund, from which
12		acquisitions of land both within and outside the boundaries of the Nation could
13		be made, subject to appropriation by the Tohono O'odham Legislative Council;
14		and
15	WHEREAS,	the Realty Office is authorized to negotiate land acquisitions and delinquent tax
16		purchases in consultation with the Agricultural & Natural Resources
17		Committee, the Mine Inspector (for patented and unpatented mining claims)
18		and the Attorney General's Office, subject to final approval by the Tohono
19		O'odham Legislative Council, and is authorized to expend funds from the Land
20		Acquisition Fund for pre-purchase costs; and
21	WHEREAS,	the Realty Office prepared a budget for the Land Acquisition Fund for Fiscal Year
22		2016 and any funds not used in the FY 2016 will be available for the next fiscal
23		year; and
24	WHEREAS,	the Agricultural & Natural Resources and the Budget and Finance Committees of
25		the Tohono O'odham Legislative Council have reviewed the FY 2016 Land
26		Acquisition Fund Budget and recommend its approval.
27	NOW, THERE	EFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby
28		approves the Fiscal Year 2016 Land Acquisition Fund budget in the amount of
29		\$355,500.00, from the Land Acquisition Fund account and any funds unexpended
30		be returned to the Land Acquisition Fund account.
31	BE IT FINALL	Y RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
32		Chairperson and any designated official to expend and administer the budget as
33		attached, provided that any amendments affecting the funds or funding level is
