

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY-2015 Revenue Budget Amendment #1 for Real Property Management)**

RESOLUTION NO. 15-207

1 **WHEREAS, the Tohono O'odham Legislative Council passed Resolution No. 14-533**
2 **approving FY 2015 Revenue Budget for Real Property Management; and**

3 **WHEREAS, the Planning and Economic Development Department's Real Property**
4 **Management Program provides, for the Da Vita Dialysis and San Simon Housing**
5 **Units; and**

6 **WHEREAS, the Real Property Management Program has reviewed its FY 2015 Revenue**
7 **Budget, and has submitted a budget amendment; and**

8 **WHEREAS, budget amendment #1 allows the increase of line item 7500 Major Capital by**
9 **\$33,000; line item 7420 RM Building by \$100,000 and decreasing line item 8000**
10 **Construction by \$133,000; and**

11 **WHEREAS, no change in approved budget amount; and**

12 **WHEREAS, the Commerce and the Budget and Finance Committees of the Legislative**
13 **Council have reviewed this Budget and recommend its approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
15 **approves the Real Property Management FY-2015 Revenue Budget Amendment**
16 **#1 in accordance with the budget attached:**

- 17 **1. Approve the increasing and decreasing of Capital Expense line items.**
- 18 **2 Approve no charge to budget total \$516,000.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairperson and any designated official to expend and administer the budget,**
21 **as attached, provided that any Amendments affecting the funds or funding level**
22 **is submitted for further prior approval by the Tohono O'odham Legislative**
23 **Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21ST**
25 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,569.2 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and 357.7 [09] ABSENT, pursuant to the powers vested in the Council**
27 **by Article VI, Section 1(d)(2) and 1(d)(3) of the Constitution of the Tohono O'odham Nation,**
28 **adopted by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting**
29 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section**
30 **16 of the Act of June 18, 1934 (48 Stat.984).**
