

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting June 11, 2015 Special Session To Address Centers for Disease Control and Prevention**  
**Grant and to Address SB 1092)**

**LEGISLATIVE ORDER NO. 15-208**

1 **WHEREAS, the Legislative Council is vested with the power "to establish rules and**  
2 **procedures to regulate all meetings of the Tohono O'odham Council, standing**  
3 **committees, boards and special committees." (Constitution of the Tohono**  
4 **O'odham Nation, Article VI, Section 1(a)); and**

5 **WHEREAS, the Legislative Rules of the Tohono O'odham Legislative Council vests the**  
6 **Council with the authority to "by majority vote, call for a special session"**  
7 **(Legislative Rules of the Tohono O'odham Legislative Council, Article I, Section**  
8 **1.D.1.); and**

9 **WHEREAS, the Commerce Committee has requested a May 28, 2015 special session to**  
10 **address a Tohono O'odham Gaming Enterprise commitment letter.**

11 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it sets a**  
12 **special session on May 28, 2015 to address a Tohono O'odham Gaming**  
13 **Enterprise commitment letter.**

14 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup> day of**  
15 **MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0- AGAINST;**  
16 **[01] NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article VI,**  
17 **Section 1(a) of the Constitution of the Tohono O'odham Nation, adopted by the Tohono**  
18 **O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
19 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934**
