

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Department of Health and Human Services, Division of Family Assistance – FY2016 Low Income Home Energy Assistance Program - Budget)**

**RESOLUTION NO. 15-209**

1 **WHEREAS, the Low Income Home Energy Assistance Program (LIHEAP) has been beneficial**  
2 **in providing financial assistance to eligible low-income households in meeting**  
3 **utility needs, i.e., electricity, propane, water and wood; and**

4 **WHEREAS, the allocation to the Tohono O'odham Nation for FY2016 through the State of**  
5 **Arizona, Department of Economic Security, Division of Aging and Adult Services**  
6 **– Community Action Program is \$62,572.00; and**

7 **WHEREAS, the Tohono O'odham Nation is hereby submitting the FY2016 budget for funding**  
8 **through the State of Arizona, Department of Economic Security, Division of**  
9 **Aging and Adult Services – Community Action Program in the amount of**  
10 **\$62,572.00 for contract period July 01, 2015 through June 30, 2016; and**

11 **WHEREAS, the Health and Human Services and the Budget and Finance Committees of the**  
12 **Legislative Council have reviewed this budget and recommend its approval and**  
13 **adoption.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves**  
15 **and authorizes the expenditures of the FY2016 Low Income Home Energy**  
16 **Assistance Program (LIHEAP) budget in the amount of \$62,572.00 in accordance**  
17 **with the attached budget and to utilize the Nation's resources pending**  
18 **reimbursement from the Grantor for the continuation of this Grant.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
20 **Chairperson and any designated official to expend and administer the budget as**  
21 **attached, provided that any amendments affecting the funds or funding level**  
22 **shall be submitted for further prior approval by the Tohono O'odham**  
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 21<sup>ST</sup>**  
25 **day of MAY, 2015 at a meeting at which a quorum was present with a vote of 2,926.9 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
27 **Article VI, Section 1(d)(2)(3) and (f) of the Constitution of the Tohono O'odham Nation, adopted**  
28 **by the Tohono O'odham Nation on January 18, 1986; and approved by the Acting Deputy**  
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the**  
30 **Act of June 18, 1934 (48 Stat.984).**


