RESOLUTION NO. 15-222

1	WHEREAS,	the Tohono O'odham Legislative Council is vested with the power to provide laws
2		"to promote, protect and provide for public health, peace, morals, education
3		and general welfare of the Tohono O'odham Nation and its members,"
4		administer Nation's lands and resources for the benefit of Nation's members, to
5		"consult, negotiate and conclude agreements and contracts on behalf of the
6		Tohono O'odham Nation" with the State of Arizona, and "to enact laws,
7		ordinances and resolutions necessary or incidental to the exercise of its
8		legislative powers." (Constitution of the Tohono O'odham Nation, Article VI,
9		Section 1(c)(2), 1(f), and1(l); and
10	WHEREAS,	the State of Arizona has taken a formal position that is injurious to the Tohono
11		O'odham Nation and contrary to law; and
12	WHEREAS,	that position infringes on the Nation's rights as a sovereign government, its
13		rights under law, and the Nation's rights as set out in the Tohono O'odham
14		Nation-State of Arizona Gaming Compact; and
15	WHEREAS,	recommendations to address claims against the State of Arizona have been
16		reviewed by the Economic Development Delegation and by the Domestic Affairs
17		and Commerce Committees, which recommend action by the Legislative
18		Council.
19	NOW, THERE	FORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes
20		and directs the Office of Attorney General and contracted legal counsel under
21	i	the attorney general's supervision to initiate and represent the Nation in
22		litigation of claims against certain officials of the State of Arizona.
